56 PUBLIC QUESTION TIME

No members of the public were present and no questions had been submitted in advance.

57 WORK OF THE INDEPENDENT COMMISSION ON CIVIL AVIATION NOISE (ICCAN)

Rupert Basham and Stephen Cooke were in attendance at the meeting to outline the work of the Independent Commission on Civil Aviation Noise (ICCAN).

The Committee receive a presentation which highlighted how ICCAN is structured, in particular that there are 5 commissioners with Robert Light as the Head Commissioner. The aim of ICCAN is to improve public trust and confidence in the management of aviation noise.

The Committee were informed about the strategic objectives of ICCAN:

- To increase trust, transparency, and clarity in the aviation noise debate
- To promote consistency, responsibility and accountability within the industry and beyond
- To establish ICCAN's expertise, authority and credibility.

A corporate strategy underpins the objectives and sets out how they will be delivered and can be found on ICCANs website. https://iccan.gov.uk/wp-content/uploads/2019 07 25 ICCAN Corporate Strategy-2019 2021.pdf

The Committee were advised that the Commission is there to assist Airports with issues such as climate change and emissions, aviation noise going forward and to provide information on best practice to Airports for dealing with noise complaints and issues. ICCAN can also assist Airports with the Airspace Change Process.

The Committee discussed the following issues:

 Carbon emissions and what the industry is doing such as aircraft fleet replacement. The type of aviation covered and not covered by ICCAN, for example military aircraft are not within ICCAN's remit.

58 CUSTOMER SERVICES UPDATE

Christina Smith provided a handout of the customer services statistics for September- November 2019. The total number of passenger engagements continued to be lower overall in comparison to the previous year.

Complaints reduced in September and rose in October. It was identified that this was due to a temporary issue with the car parking booking site.

Compliments received related to the airport being faster in terms of queue times and also users of the hidden disability lanyard.

The 10 'Happy or Not' feedback terminals had remained in the same locations as the last quarter and feedback had continued to be reviewed. The terminals were receiving on average 3,500 hits within each 24hour period and the feedback was proving useful to assisting how the airport operates.

The Committee were pleased to note that Airport staff had taken part in a shoreline litter pick as part of the 'Donate a Day' initiative. The Committee were also reassured that airport staff had been trained in the use of defibrillators.

DECIDED: That

59 QUARTERLY BUSINESS REPORT

Robin Tudor, Head of Public Relations, presented the Airport's Quarterly Business Report, covering July to September 2019. Overall, there had been a 1.7% reduction in passenger numbers compared to the previous year at this point. The overall decrease in passenger numbers was attributed to the loss of Blue Air's based aircraft.

Key points in the update for the 3rd quarter of 2019 included:

- → EasyJet had carried 700,000 passengers;
- → Ryanair carried 600,000 passengers with a load factor of 90% which was +1% compared to 2018. Their new routes, Copenhagen, Corfu and Paphos were performing well;
- → Flybe carried 30,000 passengers:
- → Wizz Air continued to grow passenger numbers following the introduction of new services:
- → Blue Air continued to perform strongly on the Bacau and Bucharest routes with a load factor of 90%, + 9% compared to 2018;

- → Wideroe Bergen continues to perform very well, with load factor increasing 33%
- → The number of movements relating to General and Business Aviation had decreased by 4% but with a greater degree of larger aircraft;
- → Vehicle crime remained low in the Airport car parks with a crime rate of 0.001%
- → The Runway End Safety Area now had the extended fence line completed and the Instrument Landing System installation was ongoing but due to be operational by 13th December.
- → The latest Airport Transport Forum had discussed a number of issues relating to the Airport Surface Access Strategy which was currently being revised;
- → The Airport had recently taken part in a number of 'Donate a Day' activities as part of the Airports People and Community Strategy;
- → In October the Airport had hosted a business networking event organised by Downtown Liverpool in Business entitled 'Trains, Planes Automobiles' and a Question and Answer session took place involving the CEO of the Liverpool City Region Combined Authority;
- → The Committee noted a number of press releases that had been released during the first quarter.

Andrew Dutton, Head of Environment provided the Committee with an update on the Airspace Change Process.

2 CHANGES IN MEMBERSHIP

There were no changes in membership to report.

3 MINUTES OF LAST MEETING

Resolved -

That the minutes of the meeting of the Noise Monitoring Sub-Committee held on 25 October 2019 be agreed as a correct record.

4 NOISE COMPLAINTS LOG

The Sub-Committee considered the Noise Complaints Log, which detailed the complaints received and the responses, for the period 1 October 2019 to 31 December 2019. Colin Barnes gave a presentation to members on the Noise Log which included analysis of the number of noise complaints received by date, number of complainants, administrative area and the total number of complaints compared to the previous year. He also detailed the number of engine test runs. During the period a total of 7,851 noise complaints had been received, although all but 21 were from one individual. Of the 21, no more than 2 had been received on any one day, with the highest number for any reason being 4 for departures on Runway 09.

Going forwards, the reports would not include the complaints for the regularly complaining individual from Warrington as highlighted in the previous meeting.

Resolved -

That the Noise Complaints Log for 1 October 2019 to 31 December 2019 be noted.

5 **AIRSPACE CHANGE**

Andrew Dutton presented this item. He provided a brief background on the work over the past two years, and on the reasons for the change, which would enable a change from ground-based navigation to satellite-based navigation. Airspace in the area had not fundamentally changed since the 1950s/1960s and Liverpool John Lennon Airport (LJLA) would also be seeking to make improvements in efficiency and resilience.

Airspace change proposed involved a seven-stage process which was overseen by the Civil Aviation Authority (CAA). Since Liverpool Airport had one runway and aircraft took off into the wind for efficiency, approaches and departures could change ends depending on wind direction. Each alignment had different routes and the challenge had been to find combinations of routes that did not conflict with one another and did not interfere with nearby airports. Combinations of six suitable options had been developed and the Airport had

moved onto the public consultation stage with the aim of full implementation in the Winter of 2021/22.

The Airport welcomed all comments from individuals and organisations, preferably directly onto the Civil Aviation Authority's Airspace Change Portal for transparency:

(https://airspacechange.caa.co.uk/PublicProposalArea?pID=28)

Members queried details of the proposals, options and the benefits of each were explained in more detail, but members were asked to look at the consultation document.

There were public workshops planned for Wednesday 12 February 1 pm to 8 pm and Saturday 7 March 10 am to 6 pm in the Cavern Suite at the Airport terminal.

Extracts from Constitution concerning Sub-Committees

- 8. SUB-COMMITTEES AND PANELS
 - 8.1 The Committee may appoint Sub-Committees to assist the work of the Committee with such membership and powers as the Committee may decide.
 - 8.2 These Standing Orders will apply to meetings of Sub-Committees except that:
 - (i) a Sub-Committee will appoint a Chairman and Vice-Chairman at its first meeting.
 - (ii) no business will be conducted unless at least three Members are present at a meeting.
 - (iii) the frequency, dates and places of meetings will be at the discretion of a Sub-Committee.
 - 8.3 The Committee may appoint Panels to consider any matter and make recommendations to the Committee.
 - 8.4 A Panel will:-
 - (i) consist of the Chairman and Vice-Chairman of the Committee and at least three other Members.
 - (ii) meet as required in private unless the Committee or the Panel otherwise determine.
 - (iii) otherwise determine their procedures.
 - 8.5 The Committee will decide at its Annual meeting whether to reappoint any Sub-Committee or Panel and may alter its membership or powers or disband it at any other time. Current Sub-Committees are detailed in paragraphs 12 and 13, below.

12 NOISE MONITORING SUB-COMMITTEE

The current terms of reference of the Sub-Committee are as follows:

- "(1) To be a technical sub-committee of the Liverpool Airport Consultative Committee.
- (2) To meet when required (but at least quarterly).
- (3) To act within the technical role identified within the Section 106 Agreement (dated 13 November 2000 between the Airport Company and Liverpool City Council), in particular to consider and progress issues related to the Airport's proposed:
 - Quiet Operations Policy
 - Noise Monitoring and Track Keeping System
 - Preferred Noise Routes
 - Sound Insulation Grant Scheme
 - Quota Count System
- (4) To ensure that the reports required to be prepared each year for the Consultative Committee are submitted in accordance with the S106 Agreement, and to advise the Committee as necessary on Noise and Environmental issues."

QUARTERLY BUSINESS REPORT

1.0 <u>Liverpool John Lennon Airport - Traffic Statistics</u>

Passenger Traffic Performance

Passenger numbers have decreased slightly during Q4 compared to the same period the previous year, with 1.14m passengers, 0.2% less than in 2018.

For 2019 as a whole, passenger numbers were almost the same as in 2018 with just over 2,000 passengers fewer. However, passenger numbers for Q4 and for the year would have been higher than last year if it wasn't for the incident involving a business jet in December. The subsequent 15 hour closure of the runway saw significant disruption for airlines and passengers, with many flights operating from Manchester and alternative airports or being cancelled. Importantly, the Airport handled in excess of 5 million annual passengers once again – the second time since 2011.

For the fourth quarter of 2019, airline highlights include:

easyJet - carried +550,000 passengers in Q4 and over 2.4m for the year. The airline announced flights to Antalya, Turkey for Summer 2020.

Ryanair - carried +400,000 passengers in the period and over 1.9m for the year. The airline recently announced that they will serve Zadar in Croatia for Summer 2020.

Flybe - carried +24,000 passengers in Q4 and over 110,000 in 2019.

Wizz Air - continues to grow passenger numbers. With +85,000 passengers during Q4, up 40% compared with last year and over 340,000 passengers in 2019, up 52% compared with last year.

Blue Air - continue to perform very strongly on Bacau and Bucharest, with a Load Factor of 80%, +11% compared to 2018 and over 90,000 in 2019.

Wideroe - Bergen continues to perform well, with load factor 7% higher than last year and passenger numbers up by 15% up and over 7,000 passengers for the year.

Lauda - carried 6,000 passengers in the period.

General and Business Aviation

The table below shows that the number of movements relating to General and Business Aviation increased by 3% for the quarter compared to 2018 and by 4% for the year.

Vehicle crime continued to remain very low throughout 2019 with a crime rate of just 0.001% for the year, with over 1.75m vehicles using the airport car parks.

2.2 Planning and Development Matters

Runway End Safety Area (RESA) works

All works relating to the Section 106 Agreement with Halton Borough Council have now been completed. Works included the creation of a new bridleway, the rehabilitation and re-opening of Baileys Lane and the closure to a proportion of Dungeon lane. The new perimeter fence around the site was completed in July with a slight deviation to its original line to avoid all exclusion zones identified during the nesting season.

Operational changes to the RESA are now at a compliant standard and notification of such has been sent to the regulator. The Instrument Landing System installation was commissioned and put into operation in December 2019.

2.3 General Airport update

Award winning Airport

At the end of November Liverpool John Lennon Airport became the winner of the Best Medium-sized UK Airport at the 2019 British Travel Awards. Voting for this award was based on a public voting system. A week later the Airport was announced as the winner of Best Airport (3-10 million passengers) at the 2019 Airport Operators Association (AOA) Annual Conference, voted for by Airlines UK, a trade organisation that represents UK airlines.

Both awards were in recognition of the Airport's success in offering a best in class passenger experience and becoming the Faster, Easier, Friendlier Airport of choice for passengers from across the region.

Ministerial visit & the Regional Air Connectivity Review

The Aviation Minister, Paul Maynard visited the Airport in January to launch his UK tour of regional airports, as part of the Department for Transport's Regional Air Connectivity Review. The review was launched as part of a series of measures to support regional connectivity across the UK, with The Department for Transport working closely with the aviation industry, local regions and devolved nations, to identify how it can support connectivity.

Sustainable Aviation

The Airport's CEO recently attended an event in London alongside other aviation industry executives who are all members of Sustainable Aviation, to sign a pledge committing to cut carbon emissions to zero by 2050.

A new "Decarbonisation Road-Map: A Path to Net Zero" was also published by Sustainable Aviation setting out exactly where reductions can come from, including through smarter flight operations, new aircraft and engine technology, modernising UK airspace, the use of sustainable aviation fuels, and high quality market-based policy measures.

With these actions, the UK will be able to grow passenger numbers by 70% - in line with current projections - whilst reducing net emissions from 30 million tonnes of CO2 per year today down to zero.

Sustainable Aviation is a long term strategy which sets out the collective approach of UK aviation to tackling the challenge of ensuring a cleaner, quieter, smarter future for the aviation industry. Launched in 2005, it is a world first bringing together major UK airlines, airports, manufacturers, air navigation service providers and key business partners.

Airport Transport Forum (ATF)

The next meeting of the ATF has been postponed until the end of February whilst the revised Airport Surface Access Strategy (ASAS) is being prepared. This will be discussed at the next ATF and a copy of the final document will be shared with the LACC at the next meeting.

Downtown Liverpool event hosted at LJLA

Earlier this month, the Airport hosted a business networking event organised by Downtown Liverpool in Business with guest speaker City Mayor Joe Anderson focusing on transport and infrastructure and joined by CEO of the Airport John Irving, participating in a question and answer session on a variety of local transport issues
